## 2020-2021 GLOBAL CORNERS INTERNATIONAL STUDENT RECRUITMENT AND RETENTION AWARD

Application Deadline: March 1, 2020

The Division of Global Engagement is pleased to announce the 2020-2021 Global Corners International Student Recruitment and Retention Award. Inaugurated with the 2014-15 academic year, the Global Corners award is given to international students of extraordinary promise and accomplishment whose recruitment and retention help to advance the University of Oregon's strategic interests in internationalizing the campus and maintaining a globally diverse student population. The Division of Global Engagement is especially interested in receiving applications from students who will contribute to the academic excellence and global diversity of our campus, and whose work exemplifies a passion for addressing the collective challenges facing our world in an era of contentious globalization.

## **Award Eligibility**

For the 2020-2021 academic year, the Division of Global Engagement is accepting applications from new or continuing international students either admitted to or continuing in a University of Oregon academic program starting with the Fall 2020 term. Continuing University of Oregon students must be in good academic standing and hold valid F-1 or J-1 immigration status. Both undergraduate and graduate international students may apply.

## **Award Amount and Renewability**

The Global Corners award provides financial support up to, but not exceeding, US \$45,000 (\$15,000 per quarter; no award funds are distributed during the summer term). The exact award amount may depend on whether the student receives other forms of financial assistance – including scholarships, on-campus employment, stipends, etc. – to support their education at the University of Oregon. The award may be used to support required tuition and fees and/or non-qualified expenses such as room and board. (Note that any amount applied to non-qualified expenses may be considered a taxable contribution.)

The award is renewable beyond the first award year, up to a maximum of 12 quarters for undergraduate students and 8 quarters for graduate students. The award may be prior to reaching the maximum award renewal level if any of the following circumstances apply: the student completes the UO academic program for which the student was granted the Global Corners award; the student receives other scholarships or grants rendering the Global Corners award unnecessary; the student departs the University of Oregon temporarily or permanently, or otherwise fails to meet award maintenance criteria and requirements.

#### **Mandatory Participation in ICSP**

The Global Corners awardee will be required to participate as a member in the Division of Global Engagement's International Cultural Service Program (ICSP) and fulfill ICSP cultural service and academic requirements. ICSP program participants provide cultural service to the UO and local Eugene / Springfield community through presentations and participation in events that help to encourage cultural exchange. Students interested in the Global Corners award do not need to submit a separate ICSP application, unless they wish to be considered for both scholarship opportunities independently.

## **Department Contribution**

For the 2020-2021 academic year, department contributions toward defraying the student's educational costs are not required, but strongly recommended. Departments are encouraged to provide letters of support that detail the amount, level, and type of financial support being provided. Note that graduate students receiving a full-year graduate employee (GE) appointment will be considered to be fully funded by the appointment, and no additional funding is anticipated through Global Corners in this situation.

#### **Award Maintenance**

In order to qualify for award maintenance beyond the first year, the awardee must meet the following criteria:

- Maintain a grade point average of 3.0 or higher (or the equivalent standard deemed to constitute superior academic performance by the student's academic program), and make satisfactory academic progress toward meeting degree requirements
- Participate effectively in ISSS's International Cultural Service Program (ICSP)
- Serve as an ambassador for the Global Corners scholarship program by participating in interviews or other outreach efforts
- In consultation with ISSS, engage in activities and initiatives aimed at expanding and enhancing the global diversity of the University of Oregon
- Maintain valid academic and immigration status under applicable UO academic and federal immigration regulations, guidelines and policies

## **Application Procedure and Deadlines**

Interested students should submit an application packet to International Student and Scholar Services no later than the application deadline of March 1, 2020. The student applicant is responsible for preparing all required documents and sending them by the deadline to the Division of Global Engagement by mail or by email at issa@uoregon.edu:

#### 1. Global Corners Application Information Sheet

The student applicant must complete an application information sheet that provides personal and contact information as well as information regarding the student's anticipated financial resources and needs for the award year.

### 2. Student's Application Statement

The application statement should be typed or printed by the student and be no more than 500 words in length. In the statement, the student should describe the following points:

- Capacity for academic excellence: The student should explain his/her academic and
  career interests, showing how these inform the student's purposes for studying at the
  University of Oregon. The student is also encouraged to describe their academic
  potential, achievements, accomplishments, and capacity for academic excellence in
  their chosen program at the University of Oregon.
- Campus contribution: The student should describe how his/her cultural experiences
  and background as well as personal interests, affiliations, and aspirations will motivate
  the student to excel at the University of Oregon, increase the academic and cultural

- vitality of the campus, and help to advance knowledge, research, action and insight into contemporary challenges facing today's societies.
- Commitment to meeting global challenges: The student should explain how their academic and professional interests and activities are relevant to or address the challenges facing today's different societies in an era of contentious globalization.
- 3. Transcripts from the University of Oregon or Most Recent Academic Institution
  Transcripts should detail recent academic performance, whether completed at the
  University of Oregon (for continuing students) or most recent institution of attendance (for
  new/incoming students). Unofficial transcripts are acceptable.

#### 4. Two Letters of Recommendation

The student should arrange to have a minimum of two letters of recommendation that provide a high level of support to the student's application for a Global Corners scholarship. The letters may be from current or past faculty or academic advisors, instructors, counselors, supervisors, or any other person capable of attesting to the student's potential for or record of academic excellence, commitment to cultural diversity and exchange, and service to their communities. Letters should be no more than 500 words long and provide detailed insight into the student applicant, and the potential or actual benefits to internationalization and global diversity that the student would bring to the University of Oregon community.

## 5. Optional: Supplementary Information

Students may submit supplementary information such as a resume / CV, copies of admissions applications, copies of awards / honors given, or other materials that may help to inform the Global Corners scholarship committee's decision-making process.

All application materials must be received by 5pm Pacific Time on March1, 2020. Submissions by mail, fax, or e-mail (to <a href="mailto:issa@uoregon.edu">issa@uoregon.edu</a>) are acceptable.
